What to Expect when entering Pennsylvania Live Steamers, Inc. property

With health and safety in mind, we want to let you know what to expect so you can plan accordingly should you choose to visit.



"Masks on" for all Unvaccinated Visitors Indoors & on Rides!

For the safety of our youngest visitors (who have no access to vaccinations at this time). We ask all unvaccinated adult visitors to continue to wear masks while on PLS property and on all train rides!

Proper mask wearing includes covering both mouth *and* nose with your face covering. If you are unwilling to wear a mask or unable to do so due to a medical condition, we suggest that you postpone your visit to PLS until this requirement changes.

Admission

Upon entering our property you will be greeted by a PLS representative.

- Only Members and Guests are permitted to enter PLS property.
- PLS is a private organization and the public is allowed by invitation only.
- You will be asked about you vaccination status and may be asked to show proof of vaccination.
- PLS personnel may take your temperature with a non-contact thermometer.
- All children under 12 will be required to wear a face mask. Each adult visitor and guest will be required to
 complete a release of liability form. One for each adult, minor children can be added to the responsible adult's

- Capacities will be closely monitored as we prioritize health and safety.

Train Rides

PLS has scheduled run days on the 4th Sunday during the months of April – October from 10:00 AM until 3:00 PM. Although PLS make every effort to provide train rides there is no guarantee that rides will be available and capacity may be limited.

Enjoying PLS property

- PLS has a limited number of Picnic Tables on the property. You are welcome to bring a lunch and watch the trains.
- There are 5 different track gauges (sizes) on the ground at PLS. The smallest is our Gauge 1 trains that are similar to Garden Railroad, except all powered by live steam. The largest are 1/8 scale, 7 ¼ inch gauge with many being able to pull cars with 20 plus people.
- PLS is not a fully handicap accessible facility. Many areas are wheelchair accessible, but not all.
- Port-a-Potties can be found on the property. One is handicap accessible.

Cleaning and Sanitation

PLS will be adhering to all regulations established by the State and CDC guidelines. While touch points are minimal as this is an out of doors facility, we encourage you to take advantage of the hand sanitizing stations provided.

Signage

Signage reminding everyone on-site to practice social distancing and good hand hygiene will be displayed conspicuously throughout the property.
