Dear Prospective Member:

Thank you for your interest in the Pennsylvania Live Steamers. Our club was established in 1946 as an all-volunteer organization dedicated to the preservation of the nation's rich mechanical and engineering heritage. We are incorporated as a 501(c)3 non-profit organization. Our members operate various scales of miniature railway equipment, with 1½ inch scale, 1 inch scale and Gauge 1 being the most prevalent.

We offer both Associate and Regular memberships:

**Associate** memberships are available to everyone and are welcomed without any special requirements. Associate members may attend all scheduled events and are permitted to bring guests. Although there is no work requirement for associate members, participation on work days (Saturdays and Wednesdays) and during scheduled events is surely welcomed. Associate membership dues are \$35.00 for the year.

**Regular** membership is available to everyone but is required if you own an operational locomotive with intent to operate it at PLS. Applicants for regular membership must complete a probationary period of at least one year, extendible up to two years. During this period, the applicant is required to participate actively in construction, maintenance, clerical, administrative or other approved duties at PLS on a minimum of ten occasions of not less than three hours each. Final regular membership acceptance is subject to approval by vote of the regular members after the successful completion of the probationary period. Regular membership dues are \$120.00 per year plus a one-time initiation fee of \$50.00. Regular members may:

1. Vote on matters of club business
2. Be elected to administrative office (once meeting attendance requirements are met)
3. Operate their equipment on the railroad at any time
4. Acquire storage space for railroad equipment

Please download and complete the "Application for Membership" form. Also, as condition of membership, download and complete the "Member Acknowledgement of Responsibility and Release of Liability" form. To complete the release form, read it carefully, date where noted, print name, and sign.

If the proposed member is a minor child (under age 18 on the date of signing), please complete the "Minor Associate Member Indemnification and Release of Liability by Parent(s) or Guardian(s)" form. Both parents must sign for the minor child, if possible. Otherwise, one parent or legal guardian may sign.
